### **CREDENTIAL DATES**

Effective Date	The effective date represents the date on which the credential was issued. The effective date is determined by the date the application and all needed requirements were confirmed.
Expiration Date	The expiration date represents the final date on which the credential is recognized as active.
Print Date	The date a credential has been printed and/or generated as a document. The print date has no impact on a credential's status.

## **CREDENTIAL TYPES**

One-year provisional	ne-year provisional One-time nonrenewable teaching credential that is valid for 12 months.	
Initial	Nonrenewable credential that is valid for three years for "CT" subject areas and is valid for two years for "SSP" and "ADMIN" subject areas.	
Standard	Full (i.e., no deficiencies) credential that is renewable every four years for "CT," "SSP" and "ADMIN" subject areas. Standard credentials meet reciprocity requirements for most other states.	
Endorsement	Endorsement credentials are add-on certifications for "CT" subject areas that can be issued to active standard credentials held in another teaching subject area based on passing teacher exam scores or other requirements.

ADMIN	Administrative Services Credential certification authorizes the holder to serve as a lead or assistant school principal for an elementary, middle, and/or secondary grade(s) school.				
ст	Classroom Teacher Credential certification authorizes the holder to serve as the main or primary "teacher of record" to a student or group of students in the area(s) as indicated.				
SSP	School Services Provider Credential certification authorizes the holder to serve and/or deliver support services to students in the area(s) as indicated.
